CONDITIONS OF TRANSFER OF REGISTRATION

- 1) The animal is to be inspected and approved for transfer by two persons appointed for the purpose by the General Manager.
- 2) If the animal is not identified by tattoo, it is to be tattooed with stud prefix, year of birth and a unique within-herd number by the owner and recorded on the Application to Transfer Registration as such.
- 3) A certificate of DNA parentage verification of the animal and a dry, clean follicle sample in an envelope clearly marked with the animal's tattoo identification, must be provided to Shorthorn Beef.
- 4) The owner of the animal must be a full financial member of Shorthorn Beef.
- 5) A classification fee of \$500 (exc.GST) for each bull and \$20 (exc.GST) for each female is to be forwarded with the record of inspection to Shorthorn Beef.
- 6) Shorthorn Beef retains the right to refuse the Application to Transfer Registration for any reason and no correspondence shall be entered into.
- 7) A certificate identifying the animal as being Herd Book Registered shall be issued by Shorthorn Beef.
- 8) The suffix APX shall be affixed to the animal's identification on a certificate of registration.
- 9) All costs associated with inspection of the animal shall be paid for by the applicant.
